This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

## **Definitions and interpretation**

- 2. In this privacy policy, unless the context requires a different interpretation:
  - a. the singular includes the plural and vice versa;
  - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this privacy policy.

- 3. This privacy policy applies only to the actions of Newcastle Family Funeral Directors and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Newcastle Family Funeral Directors is the "data controller". This means that Newcastle Family Funeral Directors determines the purposes for which, and the manner in which, your Data is processed.

### **Data collected**

## Data that is given to us by you

# Data that is collected automatically

9. To the extent that you access the Website, we will collect your Data automatically, for example:

- a. we automatically collect some information about your visit to the Website. - b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

#### Who we share Data with

  - b. third party service providers who provide services to us which require the processing of personal data to carry out services for cremation, burials and memorials;

in each case, in accordance with this privacy policy.

# **Keeping Data secure**

- 14. We will use technical and organisational measures to safeguard your Data, for example:
  - a. access to your account is controlled by a password and a user name that is unique to you.
  - b. we store your Data on secure servers.
- 15. Technical and organisational measures include measures to deal with any suspected data breach. If you suspect any misuse or loss or unauthorised access to your Data, please let us know immediately by contacting us via this e-mail address: ng.funerals@hotmail.co.uk.
- 16. ## **Data retention**

- 18. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

## Your rights

- 19. You have the following rights in relation to your Data:
  - a. **Right to access** the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
  - b. **Right to correct** the right to have your Data rectified if it is inaccurate or incomplete.
  - c. Right to erase the right to request that we delete or remove your Data from our systems.
  - d. **Right to restrict our use of your Data** the right to "block" us from using your Data or limit the way in which we can use it.
  - e. **Right to data portability** the right to request that we move, copy or transfer your Data.
